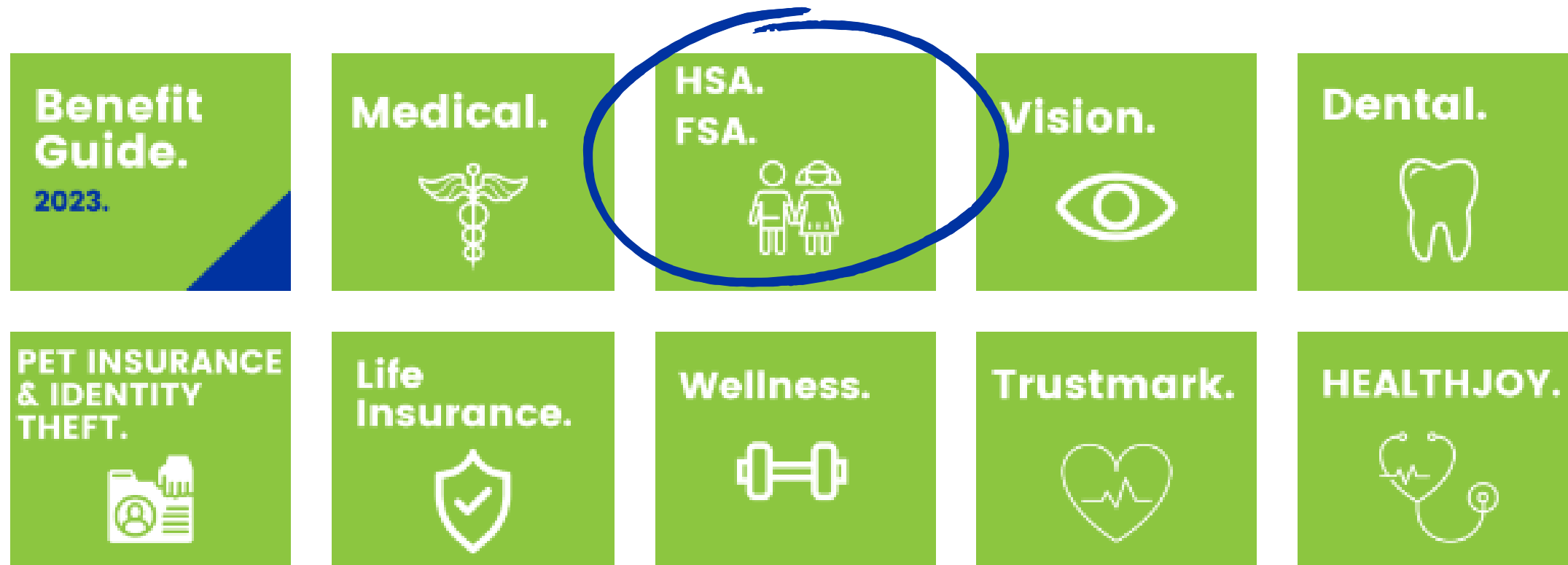

Review Eligibility Requirements

In order to open an HSA, you must have a qualifying health plan. The following questions are designed to assist in determining if you are eligible for an HSA. What this means for you: When you open an HSA account, we will ask for your name, address, date of birth, and other information that will allow us to identify you. We may also ask to see your driver's license or other identifying documents.
